### Area of competence and Status

ATLAFCO was established in 1989 and reinforced through an intergovernmental agreement adopted in 1991, which entered into force in 1995

The area of competence of ATLAFCO is the Central and Southeast Atlantic, from Namibia until Morocco, including waters under national jurisdiction and high seas. ATLAFCO covers all living marine resources within its area of competence.

The Conference of Ministers

- Governing and decision making body
- Determines the objectives and principles governing and the objectives to be implemented
- Holds sessions once every two years

### The Bureau

 Coordinating organ of the Conference of the Ministers

 Constitutes a follow-up committee of the Conference

### The Secretariat

 The Secretariat is the executive body of the Conference

ATLAFCO's offices are located in Rabat, Morocco according to the Headquarters' Agreement between ATLAFCO and the Government of the Kingdom of Morocco



# **Objective/mission**



The main objective of ATLAFCO is an effective and active co-operation between Member States for conservation and sustainable development of fisheries in the region by:

- promoting an active and organized co-operation in the area of fisheries management and development in the Region;
- taking up the challenge of food self-sufficiency through the rational utilization of fishery resources;
- stimulating the national economic sectors through the direct and secondary effects resulting from fishery resources exploitation;
- enhancing, coordinating and harmonizing the efforts and capabilities for the purpose of conserving, exploiting, upgrading and marketing fishery resources;
- reinforcing solidarity with African land-locked States and geographically disadvantaged States of the Region.
