



## THE GUIDANCE



### Inputs, comments and suggestions from stakeholders:

- → Different international and national workshops
- → Participation in other events linked to social sustainability in fisheries: Seafish/GSSI/ GFCM/etc.
- →e-consultation GLOBEFISH website
- → Declaration in the CONXEMAR/FAO Congress (Sep 30)





- → Practical and pragmatic **guidance**
- →Close to daily business operations
- → Not a new standard but a reference tool
- → Compilation of different international instruments linked to responsible business conduct, human and labour rights
- →Inclusion of all actors along the fisheries and aquaculture value chains





- → **Objective**: provide practical support for business enterprises for securing socially responsible fish and fishery value chains
- → <u>Target audience</u>: applicable by any business enterprise along the fish and fishery value chains, regardless of size, nature (private or public), or nationality (domestic and foreign)
- → Risk-based approach due diligence
- → Analysis of existing international instruments
- → Identification of risks and subsectors (fishing operations, aquaculture, fishing processing, fish distribution and trade)
