What is new in the EFCA work for 2025?



Main deletions in the activities from 2024 to 2025:

- The Project "Analysis for the weighing process of fisheries products in the Member States and strategy" was concluded in 2024
- The Project "Mediterranean virtual regional training academy on fisheries control and inspection" that will conclude in January 2025.

New tasks

- The activities under the new Objective 7: Innovation and preparation of the revised fisheries control regime:
 - Develop a roadmap for the implementation of the new tasks assigned by the revised Fisheries Control Regulation to EFCA in support to the Commission and the Member States
 - Support provided to the Commission and Member States for the implementation of the revised Fisheries Control Regulation
 - Preparation of the new tasks for EFCA as regards REM systems, lost gears, risk assessment of engine power and compilation of annual reports from Member States

The preparation and implementation of possible new projects in Western (WASOP), Central Africa and Southwestern Indian Ocean (SWIOP) under Objective 6.



- Promoting principles and standards under Union law beyond EU waters
- Level-playing field for EU & non-EU operators
- Implementation is discussed and agreed between DG MARE & EFCA





EFCA Actions 2025

- Implementation of International Control Schemes through JDPs
- Assisting EU in their Relations with Regional Fisheries Management organisations (RFMOs) & third countries
- Support to implementation of control aspect of EU IUU fishing Catch Certification scheme (workshops, exchanges)
- Analyses of catch certificates and processing statements issued by third countries

International projects

- Algeria: Support to implementation of VMS
- West and East Africa: Capacity building activities, support to operational activities & implementation of specific projects

- Standardised and harmonised implementation of fisheries control activities at international level
- Equal treatment of operators in EU & international areas

Actions

- Assistance and cooperation with the European Commission on analysis of documents and evaluation mission to third countries as regards the implementation of the IUU Regulation
- Increased collaboration with Commission and Member States IUU competent authorities in the CATCH project,
- FAO Agreement on Port State Measures to Prevent, Deter and Eliminate IUU fishing (PSMA)

International Projects




Projects will follow the scheme of PESCAO:
