## Procedure for Election Chairs & Vice-Chairs of the WGs

In accordance with LDAC rules of procedure, the Chairs and Vice Chairs of the Working Groups will be elected amongst its membership at each respective Working Group.

Title III, article XXVI:

#### Proposed procedure (Secretariat will act as coordinator):

- Launch a new call of interest for Chair and/or Vice Chairs (note: we have already candidates acting as interim coordinators).
- Inform on applications of interest received in writing before the meeting.
- In case there is more than one candidate for the same position, a vote will take place by secret ballot (virtual confidential poll) at the forthcoming Working Group meetings in March-April 2021.
