Core Work Priorities for Y16 (I)

<u>1- International Ocean Governance</u>

- To be actively engaged in the shaping and design of the IOG agenda and respond to future EU targeted consultations.
- To formulate recommendations on coherence between the CFP and other sectoral EU policies internationally.
- To provide stakeholders' views (either formal or informal) prior to some/all of the key negotiations taking place in the context of RFMOs and relevant international fora dealing with fisheries (e.g. UNGA resolution on sustainable fisheries, UN Ocean Conference SDG14, FAO COFI, etc.).
- Follow other global processes with linkages between environmental conservation and fisheries management (CBD, IUCN, BBNJ, ISA).

2- Promotion of Level Playing Field of fishing products

- To follow up recommendations and specific advice drawing from the LDAC advice of May 2021 identifying areas of uneven internal and external dimension in the field of fisheries with regards to aspects related to access to fair competition, traceability of products and value chains, transparency of fishing activities and access to EU market.
- To engage in active dialogue with DG MARE and request also participation of DG TRADE/EMPL/SANTE on this subject.





Work Priorities for Y16 (II)

3- Social Dimension of the CFP

- To continue working with the EU Social Dialogue Committee to implement the agreed road map with specific deliverables and actions for 2022 and beyond.

- To assist DG MARE team in relevant international fora asking for the promotion of labour, social and human rights related to fisheries in the EU agenda.

- To request EU flag Member States to foster the adoption, transposition, ratification and implementation of key international legal instruments;

- To formulate specific recommendations and ideas on how to improve working and living conditions and social sustainability of the fisheries value chains.

- To initiate a technical discussion on methods of measuring fishing capacity with the aim to improve safety at sea and ensure decent working conditions onboard.

4- Evaluation of Sustainable Fisheries Partnership Agreements (SFPAs) with Third Countries

- To provide ongoing feedback to DG MARE and follow closely the outcomes of the study on retrospective evaluation of SFPAs within the framework of the EU report on the CFP (expected to be launched by the end of 2022).

- To look at specific impacts of SFPAs on: marine environment, including by-catch and non-targeted species; socio-economic conditions; transparency of value chains and trade flows.



Work Priorities for Y16 (III)

5- Regional Fisheries Management Organizations (RFMOs)

To provide input to the EC designated negotiation teams of key regional fisheries management organizations, either in the form of writing input/advice (e.g. NAFO, ICCAT) or by active participate in preparatory technical coordination meetings (IOTC, WPFC...).
To develop a proposal to define the role of the RFMOs in the context of BBNJ process.

6- EU Fisheries Control Systems - Implementation of Fight against IUU Fishing (IUU) and SMEFF

- To follow up the legislative process and negotiations for the adoption of the review of the EU fisheries control system.
- To improve the effective implementation of the IUU Regulation (in particular CDS) and the SMEFF Regulation.
- To invite the DG MARE to provide regular updates and exchange views at WG5 meetings on state of play of EU carding system.
- To develop country-specific advice on IUU regulation (e.g. China, Morocco, Ecuador...)

- To continue playing an active role as member of the Advisory Board of the EFCA and addressing the consultation on the evaluation of the EFCA Independent External Evaluation for 2017-2021.

7- Climate change and impacts on fisheries

- To consider how specific impacts of climate change might affect to international fisheries management and conservation of the marine environment. In particular, the LDAC (either on its own or via cooperation with other ACs) will look at topics such as energy efficiency and reduction of CO2 (alternative energy sources and engine modifications) or changes in migration patterns of big and small pelagic stocks, amongst others.





Work Priorities for Y16 (III)

8- Role of artisanal fisheries from non-EU coastal states in fisheries

-To investigate how the CFP External Dimension can contribute to support development of fishing communities in Africa.

This can be materialised with specific actions:

- Organise side events in international meetings in 2022 and 2023 to support and promote the International Year of Artisanal Fisheries and Aquaculture (IYAFA) designated by UNGA;

- Develop with external partners (COMHAFAT, AFRIFISH, IOC) specific initiatives to support innovation and creation of value addition in African Artisanal Fisheries Value Chain;

- Promote a precautionary approach for the development of human economic activities in the EU Blue Economy;

- To strengthen visibility and recognition of contribution of EU fishing investments in third countries for development of coastal communities in third countries – organize a workshop aimed to identify strengths and weaknesses on the basis of case studies.
