# SPEAKERS



## Roberto ALONSO

### Secretary General ANFACO-CECOPESCA.

Roberto Alonso is Secretary General of ANFACO-CECOPESCA, a private organization with 121 years of history and which brings together more than 250 companies from the Spanish sea-industry complex, including a leading Technological Center with more than 100 researchers. In his professional work, he represents and defends the strategic elements for the competitiveness of companies, interacting with various organizations (FDE, FAO, WTO) and public entities, participating in the advisory councils of the European Union (LDAC, MAC, CCSUD), in the European industrial association AIPCE-CEP, ESSA or EUROTTHON presidency, as in various innovation initiatives such as the Technology Platform for Fishing and Aquaculture PTEPA, as Vice-President, or the Datalife HUB, as well as collaborating punctually in the execution and dissemination of R+D projects. He has a degree in Industrial Engineering as well as a master's degree in Industrial Innovation from the University of Vigo, and also he has completed the LEAD program taught by Stanford University in Corporate Innovation.



## Neil ANSELL

### Senior Officer for International Dimension, EFCA.

Neil Ansell is an international fisheries control expert with over 25 years of experience, including initially as a fisheries observer and inspector in a variety of fisheries and then as an MCS consultant in a number of regions most notably as a Technical Adviser on EU funded MCS projects in the Western Indian Ocean and East and West Africa. He then moved to the European Commission in DG Mare where he focused on international control policy, IUU and RFMOs. He has been in EFCA since 2013 and has worked on both operational and policy aspects of international fisheries involving close cooperation with DG Mare, international organisations, non-EU countries and a range of stakeholders. He is currently the Chair of several RFMO panels on control matters, including the PWG in ICCAT, the Compliance Committee in GFCM and the WPICCM in IOTC.



## Yobana BERMÚDEZ

### Director General of Conxemar.

She holds the presidency of the MAC (Market Advisory Council) and CEP (European Federation of National Organizations of Importers and Exporters of Fish), both European bodies based in Brussels.

Since her appointment as Director General of Conxemar, she has led the implementation of the association's first strategic plan with a 2026 horizon, aimed at addressing the challenges facing the seafood processing and marketing sector.



## Carlos BOTANA

### President of the Port Authority of Vigo.

His work involves permanently representing the Port Authority and its Board of Directors in any act and contract, and before any natural or legal person, whether public or private, in both judicial and extrajudicial settings, without prejudice to the delegation powers granted to the Board of Directors as provided in Article 31.2 of the Revised Text of the Law on State Ports and the Merchant Marine (TRLPEMM).

## Benoit CAILLART

**Director, F&S sarl.**

Benoit Caillart has a PhD in fisheries management (Agrocampus Rennes, 1984). After starting his career in fisheries research (IRD, South Pacific Community), Benoit worked in the field of expertise in support of fisheries management. In this capacity, he is one of the main experts in charge of evaluating the external dimension of the Common Fisheries Policy on behalf of the European Commission, in particular the Sustainable Fisheries Partnership Agreements (SFPAs) signed between the EU and various third countries in the Atlantic, Indian and Pacific Oceans. Benoit has also worked on strengthening international ocean governance, including Regional Fisheries Management Organisations (RFMOs) and the promotion of international instruments aimed at improving the environmental and social sustainability of the fishing sector worldwide.



## Roberto CESARI

**Head of Unit, European Commission DG MARE Unit B4 – Illegal, Unreported and Unregulated fisheries.**

Head of Unit at the European Commission, Unit B.4 "Illegal, Unreported and Unregulated Fisheries Policy". This Unit is responsible for implementing the European Union (EU) IUU Fisheries Policy under the EU Council Regulation N° 1005/2008 ("IUU Regulation"). Mr Cesari possesses thirty one years' experience in fisheries management within the European Commission and, for the past twenty eight years, he has been responsible, at various levels, for the European Union multilateral and bilateral international fisheries policy (EU Head of Delegation in various Regional Fisheries Management Organisations as well as Chief negotiator for the EU Sustainable Fishery Partnership Agreements and now, lead negotiator for the EU IUU dialogues with third country partners).



## Ángela CORTINA

**Technical Secretary for ARVI's Distant Water Fleets.**

Ángela Cortina has a degree in Marine Biology and a PhD in Marine Biotechnology and Aquaculture from the University of Santiago de Compostela.

In 2018, she joined ARVI's R&D&I department, where she participated in and coordinated projects related to fishing efficiency and sustainability, improving life on board, and compliance with legislation.

Since 2022, when she became technical secretary for the DWF, Ángela works closely with longline fleets in highly migratory fish RFMOs, bottom longline fleets in the Indian Ocean, and freezer trawlers in NAFO, the Southwest Atlantic, and Northern Europe, serving as a link between administrations and shipowners.

Additionally, since 2024, Angela has been vice-chair of Working Group 4 on Bilateral Relations with Third Countries of the LDAC.



## Julien DAUDU

**Chair of LDAC Working Group 5 on Horizontal Issues. Environmental Justice Foundation (EJF).**

Julien Daudu is the Environmental Justice Foundation (EJF)'s Chief Representative in Brussels, where he engages with key EU staff across the organisation's range of activities. Julien also participates in EJF's ocean-related investigations, building on his experience of working on fisheries-related issues – and more specifically the fight against illegal, unreported and unregulated (IUU) fishing and associated human rights abuses – for more than a decade, across a wide range of geographies. Since 2020, Julien has chaired Working Group 5 of the Long Distance Advisory Council (LDAC). Working Group 5 covers horizontal matters such as international ocean governance, IUU fishing and labour issues.

# SPEAKERS



## Taoufik EL KTIRI

### Executive Secretary of COMHAFAT.

Shortly before his appointment to the Ministerial Conference on Fisheries Cooperation between African States bordering the Atlantic Ocean (COMHAFAT), as Executive Secretary, Mr Taoufik El Ktiri worked at the Ministry of Agriculture and Maritime Fisheries, Aquaculture, Department of Maritime Fisheries, as Director of General and Legal Affairs, a post he held from 2016 to 2024. He was previously Director of Maritime Fisheries and Aquaculture from 2013 to 2016.

An engineer by training, a graduate of the Institut agronomique et vétérinaire Hassan II in Rabat (Morocco) and holder of a Master's degree in Business Administration from the Université du Québec à Trois-Rivières in Canada, Mr El Ktiri joined the Ministry of Maritime Fisheries in 1998 as an engineer.

During his career, Taoufik El Ktiri has contributed to the development and implementation of national fisheries management plans, the modernisation of the small-scale and coastal fishing fleet, the introduction of control and monitoring systems for fishing activities, and the drafting of several regulatory texts to govern the development of fishing and aquaculture as part of Morocco's national fisheries development strategy 'Halieutis'.

As Morocco's delegate to international organisations such as ICCAT and the GFCM, he has demonstrated his commitment to the conservation of fisheries resources and shared stocks.

He also steered the national coastal development programme, which involved the construction of landing points and fishermen's villages. This programme also led to the construction of 6 landing stages for small-scale fishing in several countries on the continent (Senegal, Guinea, Côte d'Ivoire and Congo Brazzaville) as part of the cooperation between Morocco and these countries.



## Ramón DE LA FIGUERA

### Sustainable Fisheries Director.

Ramón de la Figuera Morales holds a veterinary degree from the Complutense University of Madrid and a Master's degree in Evolutionary Biology from the same university. In 2006, he joined the National Veterinary Body, attached to the Ministry of Agriculture, Fisheries, and Food (MAPA), where he has developed his professional career.

Since 2024, he has held the position of Sustainable Fisheries Director. Previously, he was appointed counsellor at the Permanent Representation of Spain to the European Union and before he headed the Subdirector General for National Fisheries, Community Waters, and Aquaculture, and the Subdirector General for Regional Fisheries Agreements and Organizations.



## Ignacio FRESCO

### Senior Policy Advisor, OCEANA.

Ignacio Fresco Vanzini is a lawyer and policy advisor with extensive experience in civil society organizations focused on ocean sustainability and fisheries governance. He currently works to combating illegal, unreported, and unregulated (IUU) fishing and promoting transparency in the fishing sector. As a member of Oceana, he collaborates with the EU IUU Coalition on legal and policy matters related to distant-water fishing. His work focuses on legal advocacy, fisheries policy analysis, and investigative research on key issues such as fisheries control, AIS monitoring, vessel beneficial ownership, and stock management. He actively engages with national and EU institutions to strengthen regulatory frameworks and enforcement mechanisms in the fight against IUU fishing.



## Raúl GARCÍA

### Senior Fisheries Officer at WWF Spain.

Raúl García was born in Oviedo and has grown up in A Coruña. Since he was a child he has been devoted to the study and protection of nature. He studied Marine Sciences at the University of Vigo and since 2002 he has worked at WWF Spain as Senior Fisheries Officer, coordinating its fisheries program. Raúl is involved both in the political work of the organization, nationally and internationally, as well as in sustainable fishing projects on the ground, in about 35 enclaves. Raúl has been very involved in the recovery of Atlantic bluefin tuna and co-leads WWF's work at ICCAT and is also fully engaged in IOTC work and the rest of tuna RFMOs. He is member of the Southwest Waters Advisory Council and its vice-chair, and member of the Long Distant Waters Advisory Councils, of which he was vice president for 8 years.

## Béatrice GOREZ

### **CFFA Coordinator.**

Béatrice GOREZ has been spokesperson and coordinator of the Coalition for Fair Fisheries Arrangements (CFFA) activities since 1994. This included extensive collaborations with African artisanal fishing organisations and advocacy towards EU institutions on EU-African fisheries policies that affects African fishery dependent coastal communities.

Prior to becoming CFFA spokesperson and coordinator, Béatrice GOREZ was employed by the International Collective in Support of Fishworkers (ICSF) in its Brussels secretariat. She has also been employed, or volunteered, in various initiatives, such as the Fair Trade Max Havelaar Foundation, or the Belgian Green Party.



## Gaoussou GUEYE

### **President of the Continental Platform of Non-State Actors in Sustainable Fisheries and Aquaculture (AFRIFISH-Net) and President of the African Confederation of Artisanal Fisheries Professional Organisations (CAOPA).**

Mr Gueye has been working in the fishing industry for 30 years. For some time now, he has dedicated himself to the functioning of professional organisations in the African artisanal fishing sector, while at the same time engaging in capacity-building for stakeholders and advocacy for sustainable small-scale fishing. The aim is to ensure food and nutritional security for the people of Africa.

Mr Gueye is President of the continental platform of non-state actors in fisheries and aquaculture (AFRIFISH-Net), President of the Confédération africaine des organisations professionnelles de la pêche artisanale (CAOPA), and President of the Association pour promotion et responsabilisation des acteurs maritimes artisanaux (APRAPAM) in Senegal.



## Arne KINDS

### **Postdoctoral researcher at the EqualSea Lab (CRETUS, University of Santiago de Compostela).**

He has a background in biology (BSc, 2009) and marine biodiversity and conservation (MSc, 2011). He worked at Ghent University (2011-2012) and the Institute for Agricultural and Fisheries Research (ILVO) (2012-2017), focusing on sustainability assessment, fishing gear innovation, and socio-economic research topics. In 2021, He obtained a joint PhD in Economics and Bioscience Engineering from the University of Western Brittany and Ghent University, with a thesis on ownership in the French Atlantic fishing sector.

His current research examines vessel and quota ownership in the global fishing industry, combining spatial data with ownership records to uncover patterns of unsustainable and inequitable resource exploitation, particularly by Distant-Water Fishing (DWF) fleets operating in the Global South. He interprets these patterns as symptoms of deeper, structural forms of exploitation, tracing how fisheries governance is shaped by and embedded in broader systems of global trade, capital, and corporate power.



## Miguel LÓPEZ

### **President of the ConsumES Confederation**

He is an expert in consumer law from the University of Santiago de Compostela (USC) and a postgraduate from the University of Valencia, has spent over 25 years working in the defense of consumer rights and interests. He is head of the consumer defense service at UCGAL and has served as a consumer arbitrator since 1998. In 2005, he became Secretary General of the Galician Consumer Union, and since 2010, he has held the Vice Presidency of the Galician Council of Consumers and Users.

He represents Galician consumers and users in numerous advisory bodies and consultative entities in Galicia (such as the Economic and Social Council, transport, statistics, housing, tourism, and commerce), where he participates actively in consultation and regulatory development processes.

## Iván LÓPEZ

### **LDAC Chair.**

With a degree in International Relations from Vesalius College of the Vrije University Brussels, Iván López is President of the National Association of Cod Fishing Vessels (AGARBA) and General Manager of Pesquera Ancora, as well as a member of the Governing Council of the Fishing Shipowners' Cooperative of the Port of Vigo (ARVI). He is also the Chair of the EU Bottom Fisheries Alliance (EBFA) and member of Spanish Fisheries Confederation (CEPESCA) and EUROPECHE.

As manager he has worked in the processing industry and in fisheries operations in Spain, Argentina and Namibia.



## Francisco MARÍ

### **Senior Policy Officer on World Food, Agritrade and Maritime Policy. Brot fuer die Welt.**

Francisco Marí is working in the Lobby and Advocacy Department of the German church related development service "Bread for the World". Since 2004 he is lobbying against threats for food security in developing countries by EU policies and corporations. His focus is the support of self-representation of small-scale producers, especially artisanal fishermen, farmers and women in food processing.

After his studies in social psychology and law he worked during several years in Cameroon as legal advisor for a non-governmental organization and later as research and project manager on different topics in developing countries.

Francisco Mari is advisor and board member in different public and civil society organizations and author of various articles, studies and books on fisheries, standards and trade relations.



## Anne-France MATTLET

### **Deputy Director of Europêche**

Graduated from the Institute of Political Studies of Paris and the National School of Maritime Safety and Administration of France, Anne-France Mattlet began her professional career at the Departmental Directorate of Territories and the Sea in Northern France until 2016.

Subsequently, and until 2020, she was part of the French Office of European and International Affairs for Fisheries. Between 2020 and 2022, she worked as a duty officer at the Maritime Rescue and Coordination Center of the French Mediterranean.

Deputy director of Europeche, she works on fisheries policies, including economic and social aspects. She is also in charge of Europeche's tuna strategy comprising several pillars: tuna legislation and policy, governance, trade and market, scientific work and promotion of a responsible image of EU purse-seine operations.



## Julio MORÓN

### **Managing Director OPAGAC / AGAC.**

Since 2007, Julio Morón has been the Managing Director of the OPAGAC and the Association of Large Freezer Tuna Vessels (AGAC). Previously, he served as Deputy Director and Scientific Advisor to the organization in various tuna management commissions (ICCAT, IATTC, IOTC, WCPFC) and participating in fisheries agreement negotiations between the EU and Coastal countries.

Between 1994 and 1997, he was the Head of the Spanish Fisheries Office in Victoria, Seychelles, overseeing the Spanish tuna fleet's operations in the Indian Ocean across ports in Seychelles, Kenya, and Madagascar. He was also involved in negotiating EU fisheries agreements with Madagascar, Comoros, Seychelles, and Mauritius.

From 1991 to 1994, he worked as an FAO Associate Expert in the Indo-Pacific Tuna Program (IPTP) in Sri Lanka, conducting tuna research in the Indian Ocean and Southeast Asia.

In 2023 he was nominated Chair of the Confederación Española de Pesca (CEPESCA) and is also member Correspondent Academic of the Real Academia del Mar de España.

## Martin ORTH

**Team Leader and International Relations Officer International Affairs Unit DG Employment, Social Affairs and Inclusion European Commission.**

Martin holds master's degree in politics and economics. For the past 10 years, he has been working with High Seas Fish Producers Organization in Poland, where he provides legal guidance on regulatory compliance and fisheries policy. His work supports producers in navigating the complex legal landscape of the seafood sector.



## Susan STEELE

**Executive Director at the European Fisheries Control Agency.**

Born in Ireland, Dr. Steele has a degree in Marine Biology and a Ph.D. in Zoology. She completed an MBA and a Masters in Adult Education in 2007, followed by a Diploma in Business and Executive Coaching, a Certificate in Public Law, a Professional Certificate in International Regulatory Affairs, a Harvard Executive Certificate in Public Management and an International Chartered Director certification.

After completing her Ph.D. in 1998, she served as a postdoctoral researcher and lecturers and later as an instructor and head of training at BIM Regional Fisheries College. Between 2009 and 2013, she spearheaded innovation as the Head of Ireland's Seafood Development Centre.

In 2013, she joined the Sea Fisheries Protection Authority, serving as CEO and Chair until 2021. She joined EFCA as Executive Director in 2021.

With a BSc in Marine Biology, a BSc in Ecology & Evolution and an MSc in Marine Resource Management, she bridges science and policy to promote responsible fishing that supports marine biodiversity, food security, and coastal livelihoods. Since 2017, she has advanced evidence-based strategies to align environmental, social, and economic goals in fisheries policy. She also leads EU-funded projects that Europêche coordinates or participates in, focused on safety at sea, training, and decent work. Additionally, she manages the Secretariat of the EU Commission's Social Dialogue Committee for Sea Fisheries.



## Edelmiro ULLOA

**Managing Director of ACEMIX (Association of Community Enterprises in Mixed Fishing Companies).**

Graduated in Veterinary Medicine from the Complutense University of Madrid in 1986.
