Core Work Priorities for Y15 (I)

MAIN MESSAGE: BE STRATEGIC AND HAVE A REAL IMPACT ON SHAPING EU POLICIES!

1- International Ocean Governance and Level playing field of fishing products into EU market

- To assist the EU EC by providing stakeholders' advice prior to negotiations before taking place in the context of RFMOs and relevant international fora such as the UNGA, the BBNJ, IGC sessions, the CBD or the ISA.
- The LPF advice will serve as foundation to develop a number of specific pieces of advice in relation to topics such as international governance and policy frameworks, implementation of SFPAs, provisions of RFMOs, fight against IUU fishing, fisheries subsidies and labour, social and human rights; amongst others.

2- Social Dimension of the CFP

- Follow the joint work plan with the EU Social Dialogue Committee (i.e. EUROPECHE-ETF) to implement the road map adopted with specific deliverables and actions for 2021-2022. The aim is to prepare advice to the European Commission to promote a harmonized legal framework within the EU in line with internationally agreed social and labour standards for fisheries and link this process to the CFP report planned for 2022.
- The LDAC will also look to raise awareness on the need to ensure socially responsible fisheries around the world. it is envisaged to contribute as stakeholder in the FAO:FT consultation process and regional workshops set up by FAO in relation to the Guidance Document on social responsibility of the fisheries value chains.



Work Priorities for Y15 (II)

3- Evaluation of Sustainable Fisheries Partnership Agreements (SFPAs) with Third Countries

- LDAC will look at providing feedback on:

Overall SFPAs evaluation study for which LDAC is participating to the ongoing EU public and targeted consultations. The "standard" methodology and content of ex-post ex-ante evaluations for specific SFPAs under renewal. The sectoral support dimension to improve capacity building, transparency and socio-economic development of coastal communities within SFPA beneficiary countries.

4- Regional Fisheries Management Organizations (RFMOs)

- Provide timely and strategic input to the EC designated negotiation teams prior to the intersessional panel meetings, special sessions and the plenary annual meetings of key regional fisheries management organizations (i.e. NAFO, ICCAT and IOTC).
- Explore possible topics and areas for further advice on other RFMOs (NEAFC) or arrangements (CECAF)

5- Review of EU Fisheries Control Systems - Implementation of Fight against IUU Fishing (IUU)

- Working on proposals to improve the fisheries control system outside EU waters, including IUU and the SMEFF Regulations.
- Promoting a speedier transition phase from a paper-based to an electronic implementation of the EU Catch Documentation Scheme (IT CATCH)
- Providing feedback to IUU unit on specific countries incl. those linked to EU carding system (e.g. Morocco, Ecuador, Ghana)




